**Program Description and Rationale:** Describe the proposed program, including focus, overview of the curriculum, and a brief rationale for offering the program at this time and/or place.

The proposed new degree program is a master's degree program in health care professional leadership, called the Master of Healthcare Administration and Leadership (MHAL). The program is designed to provide an opportunity for the students to gain the experience and expertise necessary to lead the healthcare industry into the future and ensure quality care for the members of our communities.

The curriculum: 36 credits will be required to receive this master's degree. The program will be presented as follows: 3 (three) separate certification programs consisting of 12 credits for each certificate. Three certificates will be required to complete the master's degree. Students will be provided options to achieve their degree. Option one allows the student to receive 3 certificates (36 credits) from the ESFCOM in healthcare administration and leadership. The second option allows the student to earn 24 credits from the MHAL program and working with the Carson College of Business, one certificate (12 credits), related to business management. This opportunity provides a MHAL degree of 36 credits (24 ESFCOM, 12 CCOB). These options provide students the opportunity to expand their administration and leadership resume and, if desired, enhance their skills within the business components of healthcare. The program is designed to be completed in 2 years.

The healthcare industry is constantly in a state of flux. The only constant in the healthcare industry is the concept of change. It is becoming more and more evident that healthcare providers and administrators require an expanded background in directing the healthcare industry toward a sustainable and functionally operational structure. The highly regulated environment of a healthcare organization requires individuals with expertise in the provision of clinical care as well as health policy, law, finance, human resource management, health systems and operations. These skills require leadership focused on the future. Leadership is not management. Leadership is visionary, transformational, and committed to the community.

This program will be offered through an on-line format. The program is designed to offer three certificate programs of 12 credits per certificate for a total of 36 credits. A master's degree will be offered with completion of 36 graduate credits. Working in conjunction with the WSU Carson College of Business, a 12-credit certificate with a business focus will also be available as a component of the 36-credit master's degree. For students without the prerequisite of 3 years of experience in healthcare leadership, an additional 12 units of Foundation in Healthcare courses will be required through ESFCOM.

Students: Describe the student population to be served, and project enrollments for five years (see Demand Analysis Workbook)

The student population is designed to be composed of a diverse population of individuals. This program will provide individuals already involved in the provision of healthcare, both clinical and administrative, the opportunity to enhance their leadership and managerial skills. Healthcare is one of the major contributors to the economy of the United States. The healthcare contribution within the Spokane region is approximately 20% of the economy.

Based on Table 1 in the budget spreadsheet, we anticipate the following project enrollments over <u>5</u> years, with the program anticipated to reach full enrollment in year 2024.

# **Resource Implications:**

Proposed College/Dept. Funding (new or reallocated): This program requires funding through a net tuition funding model (tuition receipts less a central administrative "tax" returned to the offering unit).

Other Funding (please specify): Other funding sources for the new proposed degree program have not been identified at this time.

Cost of tuition is projected to be \$900 per credit for 36 credits or \$32,400 total. Tuition for instate and out-of-state residence will be \$900 per credit.

Consistent with the Carson College of Business Online Masters in Business Administration program, we propose to work with Pearson Online Learning Services, an online program enablement services company (hereinafter referred to as "Pearson) for providing services of marketing, student recruiting and management and on-line curricular content management. Cost for utilizing Pearson is 55% of gross revenue.
