- *Previewed a draft of the SBCTC Capital Budget Request for 2021-23
- *Discussed impact of current scoring methodology and the impact of this methodology on scoring projects in which a building outlived its usefulness
- *March WACTC Academy: Business Affairs Commission lead, will work with cross-representational committee to provide a president's academy on facility planning for equitable spaces
