

#### Context

- GP phased in over all 34 community and technical colleges since 2012
- March 2024 Report released with descriptive implementation statistics
- Statewide Advising Platform RFP released
- 2029 GP Outcomes Report planned
- Next GP Planning Cycle begins Winter 2026
- JFF partnering with Washington SBCTC to maximize impact of GP planning on student outcomes by taking an agile approach to drive systems change



# Our goals



#### **Guided Pathways**

- ➤ Update Guided Pathways strategy that centers KPIs, performance targets, and data and action reporting cycles in advance of the 2026 planning cycle
- ➤ Build capacity for Guided Pathways Planning through resources and tools (i.e. a new planning toolkit)
- Implement a **statewide student advising platform** at 30 institutions, building on the colleges' recent adoption of a common Enterprise Resource Planning system (ERP)





## **Key Levers**

- Strategy and coaching support
- Seed funding for PD, technology, release time, and supplemental capacity to accelerate implementation timelines
- Policy support (assessment, development, implementation recommendations, engagement and communications strategies)
- Data & Metrics

- Input into resources to help college personnel manage rapid systems change, helping them to leverage GP, the new advising platform, and other technologies.
