- O1: Identify conference theme.
- O2: Identify conference objectives and create three to five key conference outcomes.
- O3: Identify conference co-chairs and commissioners to fill other key conference planning roles.

Intersections: Equity, SEM, and GP

Part II of V

- O1: Explore, as practitioners, the intersections of equity, strategic enrollment management, and guided pathways.
- O2: Share about/Discuss the work – for the commission and at our colleges – of more fully integrating equity-mindedness and other competency frameworks on racial equity into our Washington GP & SEM work.
- O3: Engage each other in discourse about ways to actively apply equity-minded change leadership in WA GP and SEM.

Engagement: Adult Reengagement

- O1: Share progress (student identification, portal components, outreach messages) from WSAC regarding the Adult Reengagement Initiative.
- O2: Engage in discussion related to campus participation requirements and evaluate potential approaches to balance project objectives and workload, as well as to integrate the initiative with Guided Pathways and other existing efforts.

Part III of V

- O1: A brief revisit of Part I in the context of Part II to determine commission direction with regard to the workplan.

Synthesizing: Workplan Committees

Part IV of V

- O1: Integrate the analysis from Part II with the workplan objectives and actions.
- O2: Reimagine/Develop new objectives/actions as appropriate to (attempt to) achieve balance between system, institution, and professional goals.
- O3: Develop a summary report of workplan progress, as well as new directions related to existing workplan goals/objectives.

Evaluating: Workplan Discussion

Part V of V

- O1: Collaboratively appraise the achievability and value of remaining workplan goals/objectives.
- O2: Find consensus on the best path(s) forward to balance system/institutional/professional needs while fully meeting the WSSSC purpose and guiding principle(s) (EDI).

Legal Landscape with AAG

- O1: Discuss the most pressing/emergent legal topics impacting the work of the commission and institutional student services.
- O2: Analyze system impact and build plans as necessary/appropriate to respond to topics discussed.

WSSSC Discussion Topics

- O1: Discuss and problem-solve/develop appropriate courses of action in order to support and respond to pressing system questions and challenges requiring commission leadership and response.
- O2: Resolve pressing business matters of the commission.
